RE: New and Enhanced Economic Development Programs Approved During 2020-2022

The Legislature and Governor made historic investments in economic development programs to support small businesses, workers, and local economies during the COVID-19 pandemic. The following is a list of some, but not all of those programs.

Substantially all of the programs listed below were established through the budget and budget-related actions. Program descriptions were adapted from those provided by the Department of Finance and the Assembly Budget Committee. Additional details on these and other related programs may be found in the Assembly Committee on Budget's 2022-23 Budget Summary ([October 8, 2022 version](#)).

It is hoped that this list will assist Members of the Legislature, as well as the public, track implementation of these important state resources.

Small Business

- **Small Business COVID-19 Relief Grants:** \$4+ billion to OSBA at GO-Biz for the California Small Business COVID-19 Relief Grant Program. Authority added as part of the 2022-23 budget actions to increase funding and allow the flow-through of funds between small business COVID-19 relief grant programs to help ensure all eligible applicants are funded, including those applying to the California Nonprofit Performing Arts Program; California Venues Grant Program, California Microbusiness Grant Program and the Cultural Institutions Grant Program.

- **Unemployment Insurance Trust Fund Loan:** \$1.5 billion with \$1 billion made available for paying down the principle of the Unemployment Insurance Trust Fund Loan from the federal government and \$500 million (beginning as early as 2024-25) to provide rebates to small businesses as reimbursements for higher costs attributed to loan repayment.

- **Supplemental Paid Sick Leave Relief Grants:** \$250 million to GO-Biz for relief grants for small businesses and non-profits to offset costs of their employees who have utilized the state's supplemental COVID-19 paid sick leave.

- **California Competes (CalCompetes) Grant Program:** \$240 million to GO-Biz to establish the CalCompetes Grant Program and make two rounds of awards. Program changes approved in 2022 allow CalCompetes to consider a company's willingness to choose California over states that do not protect LGBTQ+ or reproductive rights, and commitment to good labor practices, in its awards.

- **California Competes Tax Credit Program:** Extends the CalCompetes Tax Credit program through 2027-28 at the current level of \$180 million per year.

- **California Venues Grant Program:** \$165 million to the OSBA at GO-Biz to provide grants of up to \$250,000 to independent venues, live events businesses, and minor league sports. Second year funding expanded eligibility to movie theaters and drive-ins.

- **California Travel and Tourism:** \$95 million to the California Office of Tourism within GO-Biz to implement strategic media recovery campaigns that will jump-start the recovery of the travel and tourism industry. The California Office of Tourism will coordinate with Visit California to implement this initiative.

- **California Small Agricultural Business Drought Relief Grant Program:** \$75 million to GO-Biz to provide direct assistance to eligible agriculture-related businesses affected by severe drought conditions.

- **California Rebuilding Fund and other Small Business Programs:** \$75 million for the IBank to support programs that provide financial assistance for small businesses. Of that amount, \$50 million for the Small Business Finance Center will address gaps in available federal assistance and will leverage existing private lending capacity and philanthropic funding and \$25 million will capitalize the California Rebuilding Fund, which provides capital to Community Development Financial Institutions and other mission based lenders to enable the origination of more loans in underbanked communities.

- **California Rebuilding Fund and other Small Business Programs:** \$50 million to the IBank to use across IBank's programs including the Small Business Loan Guarantee Program and California Rebuilding Fund, with a focus on programs that benefit underserved businesses in California.

- **California Microbusiness Grant Program:** \$50 million to GO-Biz to administer the California Microbusiness COVID-19 Relief Grant Program to assist qualified microbusinesses that have been negatively affected by the COVID-19 Pandemic. Eligible microbusinesses will receive grants of \$2,500 each. Microbusiness Grant Programs are locally administered.

- **California Investment and Innovation Program:** \$50 million to the Pollution Control Financing Authority to establish the California Investment and Innovation Program to provide technical assistance and capital access to certain community financial institutions in economically disadvantaged areas of the state.

- **California Nonprofit Performing Arts Grant Program:** \$49.5 million to provide grants of up to \$75,000 to eligible nonprofit performing arts organizations to encourage workforce development.

- **California Dream Fund:** \$35 million to OSBA within GO-Biz to support microgrants of up to \$10,000 to incentivize startups and strengthen their success outcomes. The funding will seed entrepreneurship and small business creation, especially in underserved small business groups that are facing opportunity gaps including people of color, women, and immigrant entrepreneurs. In order to be eligible, the microbusiness will have completed a start-up boot camp offered by a technical assistance provider who received funding through the Small Business Technical Assistance Program.

- **Cannabis Local Equity Grant Program:** \$35.5 million to GO-Biz for the Cannabis Local Equity Grant Program, to assist local equity applicants and licensees.

- **Social Entrepreneurs for Economic Development (SEED):** \$30 million to the California Workforce Investment Board to continue the SEED program, which provides grants to community based organizations to support small businesses in target communities.

- **Cultural Districts:** \$30 million to the California Arts Council to support the 14 existing cultural districts and expand the cultural districts program to support traditionally underserved communities that reflect the geographic and racial diversity of the state.

- **California Containerized Ports Interoperability Grant Program:** \$30 million to GO-Biz provide grants to the five containerized ports to assist in achieving real-time interoperability.

- **Technical Assistance Expansion Program and Capital Infusion Program:** \$29 million to the Office of the Small Business Advocate, including an additional \$6 million annually to increase the ongoing appropriation to \$23 million for the Technical Assistance Program and removal of the program sunset. The funding also includes \$3 million for the Capital Infusion Program.

- **California Regional Initiative for Social Enterprises—**\$25 million to GO-Biz to establish the California Regional Initiative for Social Enterprises Program to provide financial and technical assistance to employment social enterprises to accelerate economic mobility and inclusion for individuals that experience employment barriers.

- **Accelerate California: Inclusive Innovation Hub Program:** \$22.5 million to the Office of the Small Business Advocate (OSBA) at GO-Biz. In 2021-22, the program was rebranded and relaunched as the Innovation Hub program with 10 new iHub designated. The focus of the rebranded program is to incentivize a focus on diversity, equity, and inclusion in the state’s tech and science-based startup ecosystem. In 2022-23, the program was again rebranded and the number of iHubs increased from 10 to 13 to align with the Community Economic Resilience Fund regions, and to create the Entrepreneurship Fund to provide seed funding to businesses incubated within each of the Hubs.

- **Small Business Loan Guarantee Program:** \$20 million to the IBank for the Small Business Loan Guarantee Program to continue to provide loans as businesses recover from the economic impacts of COVID-19. May also receive a portion of the \$50 million approved for any IBank program serving small businesses.

- **Tourism Recovery:** \$15 million to implement strategic media recovery campaigns that will help continue the recovery of the travel and tourism industry in California. The California Office of Tourism, within GO-Biz, will coordinate with Visit California to implement this initiative.

- **Immigration Integration and Economic Development:** \$11.6 million 2022-23, and \$500,000 annually thereafter, for GO-Biz to coordinate resources and support immigrant integration statewide, enhance service provisions for immigrant communities at the local level, and support economic development activities for underserved small businesses and entrepreneurs.

- **Women's Business Centers:** \$8 million to OSBA to support Women's Business Centers help diverse business-owners and other underserved small business owners, access capital. This will support the drawdown of SSBCI funds.

- **UC Division of Agriculture and Natural Resources:** \$5.4 million to the UC Division of Agriculture and Natural Resources to provide regional community development specialist through the UC Extension Program.

- **Technical Assistance Program for Underserved Farmers:** \$5.4 million to the California Department of Food and Agriculture to support technical assistance providers and small, mid-sized, and underserved farmers. These resources help farmers with business planning, navigating regulatory compliance, and accessing additional state and federal funds.

- **Renewable Clean Hydrogen Energy:** \$5 million to GO-Biz for a grant to the Alliance for Renewable Clean Hydrogen Energy Systems for activities related to establishing a federally funded hydrogen hub in California.

- **Office of the Small Business Advocate, Outreach Engagement:** \$901,000 to the OSBA at GO-Biz to expand the program's formal duties to support small business opportunities for people of color, and designate staff to identify opportunity gaps and target engagement and outreach.

Transition to a Net-Zero Economy

- **Zero Emission Vehicle Package:** \$2.55 billion to California Air Resources Board (CARB) and includes funding to support: zero emission drayage trucks and transit buses; Clean Trucks, Buses, and Off-Road Equipment; Clean Cars 4 All and other equity programs; zero emission vehicles around ports; emerging opportunities; and Sustainable Community Strategies and other community-based plans, projects, and support.

- **Climate Action Core:** \$764.4 to OPR to OPR to support the California Climate Action Corps State Service Program, regional climate adaptation strategy development and implementation, and the Vulnerable Communities Platform and Cal-Adapt Mapping platforms.

- **Local Government Budget Sustainability Fund:** \$300 million to GO-Biz to establish the Local Government Budget Sustainability Fund to provide grants to counties facing significant challenges to their near-term sustainability that demonstrate a clear commitment to advancing a more climate-resilient local economy.

- **Sustainable Agriculture Package:** \$242 million to the California Department of Food and Agriculture for programs that create a healthy, resilient, and equitable food system; promote climate smart agriculture to support long term sustainability and resilience; and address economic recovery and high-road job growth.

- **Sustainable Agriculture Package:** \$150 million to the California Air Resources Board to provide grants, rebates, and other financial incentives for agricultural harvesting equipment, heavy-duty trucks, agricultural pump engines, tractors, and other diesel equipment used in agricultural operations.

- **Sustainable Agriculture Package and Climate Catalyst Fund:** \$25 million to the IBank for programs that create a healthy, resilient, and equitable food system; promote climate smart agriculture to support long-term sustainability and resilience; and address economic recovery and high-road job growth.

- **Wildfire and Forest Resilience Package: Climate Catalyst Fund:** \$16 million to GO-Biz as a part of a comprehensive \$1.5 billion package to increase the pace and scale of forest health activities and reduce wildfire risk.

- **Energy Efficiency Pilot Programs:** \$7.9 million to the Alternative Energy and Advanced Transportation Financing Authority to continue administering the ratepayer funded pilot programs designed to increase the availability of lower-cost financing for energy efficiency projects.

- **Zero Emission Vehicle Market Development Strategy:** \$5 million one-time General Fund for GO-Biz as part of a \$3.9 billion package to equitably scale the zero emission vehicle market and accelerate the state toward meeting its climate and transportation goals. This includes funding to support: ZEV Market Development Strategy.

- **GO-Biz Energy Unit:** \$950,000 to GO-Biz to establish an Energy Unit to provide dedicated resources to expedite critical projects and essential infrastructure with an initial focus on energy generation and wildfire mitigation.

- **Regional Climate Collaborative Program Implementation:** \$508,000 to OPR to continue work already underway to fulfill the requirements of Chapter 377, Statutes of 2018 (SB 1072).

Workforce Development – Including Climate

- **Community Economic Resilience Fund:** \$600 million one-time to the Labor Agency to implement the Community Economic Resilience Fund, which will provide resources for planning and implementation grants to support communities recovering across California.

- **Apprenticeship Innovation Funding Program:** \$175 million to the Division of Apprenticeship Standards to establish the Apprenticeship Innovation Funding program (AIF). Requires the Division of Apprenticeship Standards (DAS) to administer the program, which provides grants, reimbursements, or other funding for the support of an apprenticeship program or training of apprentices

- **California Career Technical Education Incentive Grant Program:** \$150 million increase in program funding to the Department of Education for the California Career Technical Education Incentive Grant Program.

- **Workforce Board Collaboration with Community Colleges:** \$60 million to the California Workforce Investment Board to build new partnerships with the California Community Colleges. This includes \$10 million for data improvements, \$25 million for High Road Training Partnerships aligned with community college curriculums, and \$25 million for equity partnerships between local boards and community colleges.

- **Apprenticeship Innovation Funding:** \$55 million to DIR in 2022-23 and \$60 million in 2023-24 and 2024-25 to invest in and expand non-traditional apprenticeships.

- **Re-Entry Fund:** \$52.5 to California Workforce Development Board to administer a reentry employment grant program to support and train justice-involved and previously incarcerated individuals.

- **CCC Strong Workforce Program:** \$42.4 million to Community College Chancellor’s Office to increase program funding and authorize the expansion of work-based learning opportunities at community colleges through the Strong Workforce Program.

- **Displaced Oil and Gas Worker Fund:** \$40 million one-time General Fund to establish a fund to provide assistance for oil and gas workers facing unanticipated displacement

- **Summer Youth Jobs Program Grants:** \$25 million to California Volunteers at OPR to continue the existing Youth Job Corps program.

- **Healthcare Workforce Advancement Program:** \$25 million to the Employment Training Panel to launch a Healthcare Workforce Advancement Program to support job entry and career advancement for entry-level and other workers in care, healthcare, and human services social work settings that meet high road job standards.

- **Integrated Education and Training for the English Language Learners program:** \$20 million to EDD for the Integrated Education and Training for English Language Learners Program to increase the rate at which adult basic education and English-as-a-second language students’ advance to college-level occupational programs and complete postsecondary credentials.

- **Targeted Training for Emergency Medical Technicians:** \$20 million to the Employment Training Panel for each of three years to provide targeted training for Emergency Medical Technicians.

- **Integrated Education and Training for the English Language Learners (ELL) program:** \$40 million to EDD for the Employment Training Panel to expand Workforce Literacy training. These funds shall be available for encumbrance or expenditure until June 30, 2025, and for liquidation of encumbrances until June 30, 2027.

- **Prison to Employment:** \$20 million to the California Workforce Investment Board to continue the Prison to Employment Program and build pathways for formerly incarcerated and justice-involved individuals to reenter society and the labor force.

- **California Youth Apprenticeship Program:** \$20 million to DIR in 2022-23 and 2023-24, and \$25 million in 2024-25 to establish and expand apprenticeship and pre-apprenticeship opportunities for youth.

- **Well Capping Workforce Pilot:** \$20 million to the CWDB to develop a well capping workforce training pilot program to provide training for short-term employment for impacted oil and gas workers in Kern and Los Angeles counties.

- **California Youth Leadership Program Language Justice Pathway:** \$20 million to CWDB to expand learn-and-earn community change career pathways for community college students.

- **High Road Construction Careers:** \$10 million to the California Workforce Investment Board to expand the High Road Construction Careers aimed at building pathways into jobs in residential construction.

- **Precision Medicine:** \$9.3 million to OPR to increase participation of underrepresented communities in biomedical research.

- **Microenterprise Home Kitchen Operation Grant Program:** \$8 million to the California Workforce Investment Board to establish a Microenterprise Home Kitchen Operation Grant Program with \$5 million to make competitive grants for nonprofit organizations to perform related community outreach; education and training; marketing; and negotiating preferred rates for food, supplies, equipment, and services.

- **Bachelor Degree Expansion:** \$5 million in 2022-23, and \$4.7 million ongoing, to the Department of Correction and Rehabilitation to permanently fund Bachelor’s Degree Programs at seven institutions in collaboration with the California State University system. These programs will be available to students upon successful completion of their community college programs and will enable them to prepare further to enter the workforce and find gainful employment upon their release from prison.
